Third, is our illustrious Grand Wielder and a personal friend, Terry Maloney. Terry, thank you for placing my name in nomination. Terry and I have known each other almost as long as I have known my wife. We have spent many hours together over the years, a few on the golf course, and it always seems that our discussions turn to the Blue Goose. What a privilege it is to have him as a friend. And what an asset he is to this organization. Terry, thank you for all that you have done for the Honorable Order of the Blue Goose.

A couple of years ago, Terry and I were up in Green Lake with our families, checking out the resort facilities and working on the arrangements for the 100th Birthday Celebration. Of course we had to check out the golf venue. So, one morning we decided to go golfing at Tuscumbia Country Club, site of the first Blue Goose Golf Outing in 1906. As we were about to tee off at the first hole, we heard geese cackling. We looked up and here are six blue geese - in formation, flying directly over us, down the first fairway. Terry and I are standing on the first tee, we have dropped our clubs, and are flapping our arms. I can't imagine what the people in the clubhouse thought, seeing these two guys flapping their wings. We thought we died and went to heaven. We knew we stood on hallowed ground!

In 2006 the Honorable Order of the Blue Goose will be celebrating 100 years as an organization. 100 years! That is truly amazing. Not many organizations have an opportunity to celebrate a centennial. What a special year we have to look forward to and what a special year for us to celebrate. I am sure, as our Founding Fathers relaxed at the Oakwood Hotel on the banks of Green Lake, they never thought that this organization would not only survive 100 years, but thrive for 100 years.

Let me read to you an excerpt from "The Flight to Green Lake", memorializing the twentieth anniversary of our Order.

"It was a perfect day that greeted those Ganders and their wives who were fortunate enough to have time to make the trip to the Blue Goose shrine at Green Lake where the original egg was laid and hatched back in June, 1906.

It was a sort of sentimental journey, a pious pilgrimage to a Blue Goose shrine. There, in the very hall in which the Order was established, the original crude initiation was repeated.

Many of those who took part in the first ceremony conferred the obligation upon the first Gosling, whose pin feathers were plucked twenty years before. So far as possible, the event was duplicated in every detail, and before a large crowd, which was deeply impressed by the sentimental and historical associations involved.

What was begun as a jest had developed into a great international organization, with thousands of members and widespread influence. A joke society intended to beguile the tedium of a rainy day, had grown to be the social organization of the business, promoting fellowship, charity and good will and condensing the teachings of the Golden Rule into two words of its underlying principle, "Tote Fair".

That was 1926!

Over the past 100 years, there have been many individuals that have guided and provided the leadership for this organization. PMLGG Jerry Hale, thank you for your leadership this past year and to all the PMLGG's here today, thank you for your commitment and love for this organization.

Four years ago, in St. Louis, I began my journey, as others have before me. It has been my privilege to serve as a Grand Nest Officer.

But most important are the members of the Honorable Order of the Blue Goose, International. You are the ones that make this organization great. You are the reason our organization will be celebrating it's centennial. Thanks to all of you!

Today, the Blue Goose is different than it was in 1906. But, the basic principles of our Order - character, charity and fellowship - have stood the test of time and will continue to guide us into the future as we embark upon the next 100 years.

Our Order is one steeped in tradition. It is based upon the core values that bind us together. They have provided a foundation upon which our organization was built. And, will continue to provide that foundation for many years to come.

We, as any organization, must continue to grow; we must change and adapt to the world around us. But, always remembering the basic principles upon which The Honorable Order of the Blue Goose was founded.

Let us always "tote fare" in our daily lives and strive to inculcate character, charity and fellowship.

Earlier this morning you were given a preview of the 100th Convention and special Birthday Celebration. I wish to extend to each one of you a personal invitation to join us in Milwaukee and Green Lake as we celebrate a milestone of our great organization.

In closing and as we approach our 100th year, may your zeal for our cause never waiver; may your sympathy with our interests ever grow deeper; may the bonds forged by this occasion bind us ever more closely together; for the next 100 years.

Thank you for granting me this opportunity to serve you and lead the Honorable Order of the Blue Goose, International into our next century.

**99th Anniversary
Grand Nest Convention
August 6-10, 2005 Hartford, Connecticut**

The location the Hartford Pond chose for this year's convention site was the Foxwoods Resort, the world's largest casino. There are six huge casinos under one roof, with about 30 restaurants and retail shops, and two hotels. The Foxwoods is a 5 million square foot facility which employs 12,000 employees and sits on 14,000 acres. There are about 40,000 guests who enter the facility each day. The facility and grounds are owned by the Mashantucket Pequot Tribal Nation.

We had a great attendance for the Convention...there were over 360 adults registered and 65+ children.

Sunday, August 7

This night there was a reception at the Pequot Museum, where Ganders, friends & family enjoyed a great meal, open bar and some festive song. Some Ganders did a fine job of displaying their Fred Astaire and Ginger Rogers capabilities.

Monday, August 8

The Grand Nest meeting was called to order on Monday morning, and the Presentation of colors was performed by the Governor's Foot Guard. This unit is one of the oldest Color Guard Units in the nation. The Marketing Director from Foxwoods welcomed us all to the facility, and he was followed by the Connecticut Insurance Commissioner. She stated it was organizations like Blue Goose that help regulators make the Insurance Industry look good.

Following the opening ceremony the Honorable Order of Blue Goose held a memorial Service hosted by the National Capital Pond honoring all the Ganders who have taken their long last flight. They did an awesome job of putting this memorial service in a power point format with music and a candle light type service presentation ... each Pond had a picture which depicted who they were, i.e. Texas a

lone cowboy on a horse. The presentation was very impressive.

No convention is complete without a Model Initiation. New York State Pond did the honors this year in Graucho Marx style, with the theme being "You Bet Your Flight," not "You Bet Your Life." I believe there were 12 unsuspecting Goslings, who got to take their swim in the Grand Nest Waters, lots of good humor and laughter.

Following the morning events all delegates and Ganders had lunch, at which we were entertained by a comedian – Ted Alexandro. Some of you may have seen him as he has appeared on the David Letterman show. We all left the luncheon with our sides hurting from the great laughter he created amongst us.

During the luncheon, Hartford also recognized all the Ganders who had attended 30+ conventions.

On Monday afternoon, following the luncheon, there were four committee meetings scheduled: Membership, Pond Publication, Future Conventions, and Wielders & MLG's. Each Region then gathered to review the workings of its own Region.

Following the meetings, we were off to a clam bake. We all boarded buses and took an hour ride to the ocean, where we were served clams and lobster.

Tuesday, August 9

Gerald Hale, our Most Loyal Grand Gander gave a review of his year in office. What a great year he had with some great accomplishments.

His report was followed by a report by the Grand Wielder, Keeper of the Golden Goose Egg, Historian, and our Judge Advocate.

The membership voted on the amendment that was presented eliminating the PMLGG 50% reimbursement for conventions. It passed unanimously. The amendment regarding dual membership was withdrawn for further evaluation.

Barry Snyder, PMLGG and our Grand Historian, and his wife made an offer to match up to \$1000 financial assistance for archive restoration. The hat was passed around the room for contributions and there was overwhelming offers of generosity as over \$1400 was raised in a matter of 20 minutes.

Each year at the Grand Nest meeting, Ponds are awarded various awards for their accomplishments in increasing membership, retaining membership, charity activities, Pond Publications, website development, and Pond with the most first time attendees to a conventions. The winners are listed elsewhere in the bulletin.

Tuesday afternoon was free time for the Ganders and their families to go do some adventuresome exploring in Connecticut/Rhode Island area, or just plain go to the casino and see how much they could increase their bank account.

Audit/Budget Report

This report is divided into two parts. The first part pertains to the actual work of the Audit and the second part is a personal observation of how our precept of Benevolence toward Members is practiced by our Grand Wielder, Terry Maloney.

Part #1

We were met at the airport Sunday and taken to a motel close to the meeting location. The meeting took place Monday, at the home office of Terry. He has a large professional efficient layout with an adjoining small room

Bill Wasekanes, our newest Grand Nest Officer, has been an active member in the Honorable Order of the Blue Goose International Penn Pond for over fifty years. As the Blue Goose celebrates its first 100 year, Bill becomes our most senior Officer ever to be elected to serve as the Grand Keeper for our organization.

Last year, due to Bill's passing this important milestone and his continued hard work and effort, the Penn Pond awarded Bill a life membership with a commemorative plaque, formally acknowledging this noble gander for his dedication to our fraternal order. His service to the Penn Pond has been a Most Loyal Gander and for many years, his present position has been Permanent Wielder of the Golden Goose Quill.

Our newest Grand Keeper began his career in the Philadelphia area in 1947 with Pearl, Eureka & Monarch Insurance Companies and USF&G. Through the years, Bill has been associated with the S. George Levi Agency, Waber Odell Agency, Butrus & Whalen, Louis Sigel, and currently Bill is associated with the Puleo-McFadden Insurance Associates in Plymouth Meeting, PA. As one fellow gander, Al Worthington, once noted in his tribute to bill, "Bill has been at all ends of the insurance business, commercial insurance placer, loss prevention, and sales. My second goal was to visit each region during my year as MLGG. I accomplished this goal and then some. I cannot tell you how enjoyable it was to travel throughout the United States and Canada and meet such wonderful people. I will not even try to thank all of the individuals who met with me, because I know I will forget someone's name. All I can tell you is that the hospitality that was expressed and demonstrated was absolutely magnificent.

In the Canadian Region, I had the pleasure of attending the Quebec Pond's lobster party and participate in their initiation. I also traveled to the Southern Region and visited with the Virginia Pond at their "Night at the Races" "oh yes, I broke even". In the West, I met with the wonderful members and guests of the Oregon Pond, sharing wine and cheese and helping with their initiation.
